


**MARKET SUMMARY**




Losses were recorded in MEIKLES LIMITED (MEIK.zw) which was \$100.6670 down at \$600.3128, DELTA CORPORATION LIMITED (DLTA.zw) went further down by \$90.7903 to \$1,949.9715 and MASIMBA HOLDINGS (MSHL.zw) lost \$31.9978 to \$908.6000. EDGARS STORES LIMITED (EDGR.zw) was \$3.6410 weaker at \$120.0000 and ECONET WIRELESS LIMITED (ECO.zw) decreased by \$2.3488 to \$500.0679.
